



Baller Men’s League “Player Waiver” Release of Liability Form

In consideration of being allowed to participate in the Baller Men’s League (BML) and related events and/or activities, the undersigned acknowledges, appreciates and agrees that:

1. This “Player Waiver” is in effect as of November 1st 2009 and will end April 30th 2010 and covers the BML 2009-2010 season
2. The risk of injury from the activities involved in this program could be significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk of serious injury does exist; and,
3. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the BML and Baller Sports Club, referees, volunteers, agents and/or employees, other players or participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the BML and Baller Sports Club program and any related events and/or activities (the “Releases*”), and assume full responsibility for my participation; and,
4. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest BML official or referee immediately, and,
5. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless the releases, with respect to any and all injury, disability, death, or loss or damage to person or property, whether caused by the negligence of the releases or otherwise.
6. I further agree to irrevocably grant the BML and Baller Sports Club Inc. the royalty free rights to record, reproduce, broadcast, publish, distribute, my name and likeness in any basketball and/or sports related media, whether now known or hereafter developed, in connection with my attendance and participation in the BML and Baller Sports Club Inc., including without limitation video recording and/or digital photography of such basketball game performances. I agree that I shall have no claim, title or interest in my attendance or participation or any materials produced hereunder.

I have read this waiver and release of liability, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement.

*Note: All Players, Head Coaches, Assistant Coaches and/or Team Managers must complete and submit a “Player Waiver” Form to be permitted to participate in the BML.
